Patriot Party® Representative Confirmation Form

The purpose of this document:

The Patriot Party® was formed to stop the financial bleeding and redirect America from "the cliff." Everything we do, and all that we believe and for which we stand, is about insuring the health and longevity of America so that we pass on the blessings we inherited to our children and future generations. We must not waiver from our mission.

The Patriot Party® is a collective effort. We share the same goals, morals, determination, love for country, and dedication to family members and friends. To be successful, we must act as one. We must move in the same direction and coordinate our efforts precisely, much like a finely tuned, well-crafted, high-tech machine.

To achieve our goals, we must maintain our focus and protect the Patriot Party[®] brand from becoming tarnished by unsavory characters, actions or intentions. In addition, we must not allow ignorance, indifference and traditional thinking to corrupt an otherwise pristine effort.

This document will achieve these goals. It will insure we remain a technology-based, platform-driven, political solution to America's social problems, that a higher purpose guides us, and that the application of science leads the way.

If you are reading this statement, you are a Member of the Patriot Party® and you wish to represent the Patriot Party® in general elections. At this point, you have been selected by the members of your Delegate Team to be the Patriot Party® representative on ballots for the particular federal or state office identified below. You have gained their confidence and approval.

As such, we can assume the following. (1) You are familiar with the 2 strategies and 45 policy measures featured in the 10 Planks of the Patriot Party® Platform. (2) You agree they are essential to restore, fortify and preserve America. (3) You give your solemn pledge to implement all of them at once without exception or alteration beyond working out the details in Congress. In addition to these requirements, you need to agree with several other provisions as featured in this document.

At this point, you have been selected to be a representative of the Patriot Party[®]. The next step is to become confirmed. To do so, complete and submit this document to the Team Leader of your sponsoring Delegate Team. This document will be forwarded to the Patriot Party[®] State Coordinator who will be sure your name is included on the appropriate ballots in the coming general elections.

1. I am a US citizen.

Qualifications:

Note: I have a valid birth certificate that I can produce if needed.

2. I am law abiding and not dependent on drugs or alcohol. I believe all people are equally valuable as human beings. I object to pedophiles, homophobes, racists, sexists and those who wish to undermine America and its systems of a "one-class society" and equal rights and laws for all.

Loyalties:

- 1. I pledge allegiance to the United States of America, and to the republic for which it stands, one nation, under God, indivisible, with liberty and justice for all.
 - Note: The pledge of allegiance was adopted by Congress in 1942. The pledge of allegiance is a wonderful tool in that it reminds citizens of some distinguishing characteristics that make America special.
 - Understanding that America is a republic and not a democracy is critical to the way citizens conduct themselves. How citizens should vote, protest and attempt to affect the legislative process is different in a democracy and republic. (See Plank #5 for details.)
 - In 1954, in response to fearing the spread of communism (and its promise of a heartless society void of individual rights), the words "under God" were added to the original pledge of allegiance. Although the words "under God" in the pledge cause some people concern regarding taking an official position on religion, ironically science necessitates their inclusion. *Gravity Theory* (understanding human nature) reveals that America recognizing the existence of God provides us with two critical benefits. These benefits are essential if we are to enjoy a safe and prosperous America. (See Plank #8 for details.)
- 2. I pledge allegiance to the U.S. Constitution. I will work to reverse the expansion of government, and restore the protections granted to citizens.
- 3. I pledge to stand on the Patriot Party® Platform.

 Note: I understand that, for the Patriot Party® to be effective in Congress, representatives must be united. Specifically, we must stand united on a comprehensive plan of action. As such, I pledge to adhere to the Patriot Party® Platform and to implement it in its entirety at once. I understand that the details regarding how policy measures are shaped is to be determined by Congress and the State Legislatures, fulfilling the role and duties of the representatives elected by citizens.

Knowledge:

- 1. I have read the 4-line planks of the Patriot Party® Platform, and I agree with them in principle.
- 2. I have read the explanation for each of the 10 Planks of the Patriot Party® Platform and I have a working knowledge of them.
- 3. I understand that the Patriot Party® Platform features 2 strategies and 45 policy measures that will be implemented immediately and simultaneously. The Planks must not be compromised for political purpose or personal gain.
- 4. I understand the difference between compromise and consensus, and I advocate consensus because compromise insures failure.
 - Note: The analogy of applying the correct equation to problems in math illustrates this best. Altering the correct equation by combining it with the wrong equation to appease the opposition (i.e. compromise) results in an equation that does not work every time.
 - Consensus becomes possible only when decisions are based on science as opposed to politics. Rather than play politics and compromise, I advocate the exclusive application of science and then vetting the issues until we arrive at the one correct solution to which we all agree.

 Note: The Patriot Party® is founded on science and the one goal of doing what is best for America long term. Only the combination of "science only" and "America first" makes consensus possible.

5. The science upon which all decisions will be made and upon which the Patriot Party® Platform is founded is "Gravity Theory." I have a working knowledge of *Gravity Theory* to where I can identify policy based on *Gravity Theory* versus *Spring Theory*.

Philosophy:

If I should serve as a State Senator or State Representative, local issues that go beyond the 2 strategies and 45 policy measures stated in the Patriot Party® Platform will need to be addressed. However, as a member of the Patriot Party®, I will adhere to the spirit of the Patriot Party® Platform as defined by the following principles:

- 1. Government jobs are overhead and must be eliminated if they do not fulfill a vital service.
- 2. Wages (everywhere) should be determined according to supply versus demand.
- 3. The compensation and benefits afforded to government workers come from taxes paid by citizens who are gainfully employed or who own a small business. As a matter of principle, benefits granted to employees of government should not exceed that of their employers.
- 4. Privatization wherever possible is a better solution.
- 5. The small business is the heart of America. As such, removing obstacles to success should be the focus of government. Government should attempt to encourage private enterprise and promote the American Dream in place of high pay low-pressure government jobs.
- 6. Everyone should be expected to contribute to society ("bring something to the party"). Those who do not must be regarded as second-class citizens with some rights and privileges curtailed until they become self-sufficient (not reliant on government for their basic needs).

 Note: Citizens who are disabled are (or should be) sustained by way of insurance. As such, they are not dependents and must be regarded as first-class citizens, worthy of equal rights and privileges.
- 7. America's fair-market economy must be allowed to operate without Interference, manipulation and extortion imposed by unions, government and special interest groups.

 Note: Contrary to the conventional view, America has not had a "free-market" economy since the early 1900s. Implementing rules such as no price fixing or gouging, setting standards for product safety, insuring equality in hiring and compensation, and assuring safe working conditions (with government oversight serving much like a referee) makes America's economic system a "fair-market" economy (as opposed to one that is "free-market" where anything goes).
- 8. I will advocate moral business practices, competition over socialism, supply versus demand, self-determination over government regulation, the American Dream, private enterprise over government ownership, the ability to get ahead, and reward based on effort and results.
- 9. If elected, I will work on behalf of my District (or State) as opposed to favoring those who voted for me or who share the majority opinion, or who put pressure on me to satisfy their wishes.

Restrictions:

- 1. I will not speak on behalf of the Patriot Party® beyond reciting and explaining the Planks in the Platform. I will not add my own opinions or those beyond what is expressed on the PatrotParty.info website in the "Platform" section.
- 2. In addition to honoring the Patriot Party® Platform, I will not campaign, fundraise or pander for support. When asked what I will do upon becoming elected, I will point to the Patriot Party® Platform. If asked to articulate any part of it, I will stay true to the 4-line Planks and the explanation of them as they appear on the PatriotParty.info website.

Note: The "free speech" argument is superseded by the need to protect the Patriot Party® brand. Think of the good will that will be established from elevating ourselves above the expensive and ineffective political process established, promoted and endorsed by the Democratic and Republican Parties. Think how voters will see us. From the onset, we stand on principle. This example proves that we will do what is proper, just, and beneficial for America and its citizens.

- 3. The following activities are not allowed:
 - Self-promotion or promotion of a cause beyond the Patriot Party® Platform
 - Printing and distributing materials including posters, cards and letters Note: Having other people do so on my behalf is a violation in spirit.
 - Advertising to include billboards, the Internet, and the traditional media outlets Note: Even free promotion is not allowed because some obligation may be implied.
- 4. The only fundraising allowed is that which is organized and conducted by my sponsoring Delegate Team at organized Delegate Team Events (insuring authenticity). Note: Examples include membership drives, picnics, game night, and so on.
- 5. Donations made at such events must be limited to \$20 per donation. This policy insures no representative is ever obligated to one or more supporters. Note: The Patriot Party® requires that individual donations (as opposed to those made at special events sponsored by the Delegate Team) be made online at PatriotParty.info (see the "Donate" link for details).
- 6. Total funds raised by a Delegate Team locally must be limited to the greater of \$5000 per team per election cycle or twice the fee required by the election's commission for the respective political office.
 - Note: Out of the donations raised locally, the Delegate Team should cover the cost of registration for the candidate with the elections office. Of the balance, fifty percent raised is to be forwarded to the Patriot Party[®] National Committee to help defray administrative and promotion expenses. The remaining donations may be used by the Delegate Team to offset administrative expenses.

Consequences:

Misrepresentation or violation of any part of this agreement will result in immediate dissociation with and departure from the Patriot Party®.

Note: Delegates and their respective Delegate Teams are responsible for specific duties and functions. Their

duties and functions must be conducted while pla	acing America first and the Patriot Party® above reproach.
